

## **Design drawings and material lists of solar energy devices developed at CAZRI**

Design drawings and material lists of seven solar energy devices namely, solar dryer, improved animal feed solar cooker, solar PV winnower-cum-dryer, solar cooker, solar PV duster, integrated three-in-one solar device and solar water heater, are available for commercialization purpose. The procedural steps for obtaining their details are mentioned below:

1. Choose solar energy device(s) (Please mention the name(s) of the devices in your covering letter)
2. Confidential disclosure agreement to be signed by the interested persons/parties. (Enclosed as Annexure I)
3. “Know your client” Performa to be filled. (Enclosed as Annexure II)
4. Remit amount of Rupees One Thousand only ( ` 1000/-) for each of the solar devices in the Institute account electronically\* or through a demand draft in favour of Director, CAZRI, Jodhpur, payable at Jodhpur.
5. Interested persons/parties seeking this information **for commercial purpose** shall be required to undertake an MOU with CAZRI.
