OFFICE ORDER

On the recommendation of the Institute Transfer Committee, The Director, ICAR, Central Arid Zone Research Institute, Jodhpur has been pleased to transfer Dr. M.K. Gaur, Principal Scientist (Geography), Division of Natural Resources (Division-I), ICAR-CAZRI, Jodhpur to ICAR-CAZRI's Regional Research Station, Leh in public interest as per ICAR-CAZRI transfer policy for strengthening CAZRI, RRS, Leh issued by the council vide No. NRM/5-5/2021-IA-II (EF.No.128130) dated 07-04-2022, are as under:-

1. He will stay at Leh for a period of two (2) years.
2. He will be entitled to HRA in his last place of posting outside Leh as well at the Leh at the rates admissible, as per relevant GoI orders/guidelines issued from time to time.
3. His dependents will continue to be eligible to avail medical facilities available at the original place of posting of the employee. He will also be eligible for availing the medical facilities available at Leh for the employees of RRS, Leh.
4. He will also be required to work for some time at Jodhpur/other RRSs during peak winter of Leh. TA will be paid for his journey from Leh to CAZRI, Jodhpur/other RRS and back as per GoI orders/guidelines issued from time to time. No separate DA will be given to him.

In case of duration of his stay at CAZRI HQ/CAZRI RRSs other than RRS, Leh, being less than one (01) month, he will be entitled to benefits/facilities (pay and allowances) as admissible to the government servants posted at Leh, as per the relevant Govt. of India orders/ guidelines, issued from time to time. However, in case of temporary posting out of CAZRI RRS Leh (in extreme winter) of more than 1 month duration, the facilities/benefit as admissible to employees posted at CAZRI HQ/CAZRI RRSs other than RRS, Leh shall only be admissible to him.

5. The work space, laboratory facilities etc. will be restored to him after his return to CAZRI HQ or its RRS.
6. After completion of two years of posting at Leh, which will be counted from the date of joining, he shall stand transferred back to his earlier place of posting.
7. If he wishes to continue at Leh beyond his tenure of two years, he may give his option in writing to the Director, CAZRI at least one month before the completion of his tenure of two years. This request for continuation must be at least for one year. Once an option given is considered and agreed to, the employees concerned will not be allowed to withdraw the same.



8. Any period of unauthorised absence/study leave during the period of posting in Leh will not be counted for calculating the two years period of posting.
9. Even if he is promoted to the next higher grade during the tenure of two years, he can continue in Leh till he completes the two year period, provided the cadre strength of the Institute doesn't get disturbed in the process.
10. He is required to join the new place of posting within 20 days from the issue of this office order, failing which, he is stand relieved after completion of 20 days from issue of this office order.

After issue of transfer orders, it will be the responsibility of the controlling officers of the transferred officers, to ensure compliance of the transfer orders. No leave except in bonafide cases shall be sanctioned to any transferred officer, after the issue of his transfer orders.

Extraneous and outside pressures, if brought upon the administration against the transfers made according to the pattern, shall attract the provision of CCS (Conduct Rules), 1964 as applicable to Council's employees.

The above transfer is made in public interest. Hence, he is entitled for TTA/Joining time etc., as per rules.
