

Sealed tenders are hereby invited on behalf of the ICAR (Director, Central Arid Zone Research Institute, RRS, Bikaner) for supply of Solar SPV pumping with lighting system as per details are given in the schedule to tender keeping in view the following conditions in respect of the articles indicated in the schedule to tender.

1. No advance payment will be made. However, the payment is normally made within 30 days from the date of receipt of material in good condition as per order.
2. The quantity proposed in the schedule to tender may be increased or decreased at the discretion of the authority while placing the order.
3. Tender not found according to specifications will be rejected/not considered.
4. The firm should supply the printed literature, operational manual – catalogue, leaflet etc. The firm should also supply a copy of the authorized dealership certificate of the item.
5. Tender should remain valid for 6 months from the date of quotation/Tender (sealed bid).
6. The rate should be on F.O.R. CAZRI, RRS, Bikaner basis for indigenous items.
7. No. form „C & „D for sales tax will be issued, Payment will be made at full rate , if applicable, However, the firm is required to produce the valid sales tax Registration No. The firm should also indicate PAN/TIN as per Income Tax Rules.
8. The Rates quoted should be **clearly indicated in figure as well as in words**. While quoting , it may be clearly indicated whether the items are inclusive or exclusive of VAT/ST, CST, Excide Duty, Custom Duty, Octroi, etc. either in terms of percentage or in absolute term.
9. Delivery will have to be made within 30 days from the date of issue of our purchase order or as mentioned in the purchase order within this financial year 2013-2014 **failing which placed with the firm treated as cancelled automatically.**

10. The Tender duly completed in all respect (as per instruction contained in the tender document and Tender Notice for inviting tender) may be send to the office by courier/Reg. 11. The Tender will be opened on the schedule date and time as mentioned above in presence of the representative o f the firms if they desire to attend.
12. In case of any disputes, the decision of the Director, CAZRI, Jodhpur shall be binding on the part of the firm/supplier.
13. Director, CAZRI, Jodhpur reserves the right to accept or reject any or all the tender without assigning any reason.
14. All bids must be accompanied by a bid security/Earnest money deposit (EMD) deposit of Rs. 10,000/- in the form of A/c payee DD or Bank Guarantee. Without EMD the tender will not be considered. If the firm is registered with National Small Industries Corporation (NSIC) there is no need to submit EMD (bid security).
15. **GUARANTEE/ WARRANTY** :The supplier shall guarantee that the stores, articles sold/supplied to the purchaser against this tender shall be of the best quality and workmanship and new in all respects and shall be strictly in accordance with the specification and particulars contained/ mentioned in the Tender enquiry. The supplier shall guarantee that the said goods/stores articles would continue to conform to the description and quality aforesaid for a period of 36 months, if during the aforesaid period of 36 months the said stores/goods/articles be discovered not to conform to the description and quality aforesaid or not giving satisfactory performance or have deteriorated, the decision of the purchaser in that behalf shall be final and binding on the supplier and the purchaser shall be entitled to call upon the supplier to rectify the goods/stores/articles or such portion thereof as is found to be defective by the purchaser within a reasonable period or such specified period as may be allowed by the purchaser in his discretion on/an application made therefore by the supplier and in such an event, the above mentioned warranty period shall apply to the goods/stores/articles rectified from the date of rectification thereof,. In case of failure of the supplier to rectify or replace the goods etc., within specified time, the purchaser shall be entitled to recover the cost with all expenses from the supplier for such defective stores.
16. The firm to whom place the order may/will have to furnish a performance security in the form of Bank Guarantee as per the Performa to be supplied along with supply order or FD pledged to "**ICAR Unit – CAZRI, Jodhpur**" from a scheduled Commercial Bank for an amount which may vary from 5% to 10% of the value of the contract at the discretion of Director, which should remain valid for the entire period of warrantee plus two months.
17. No part supply will be allowed.
18. Installation/Demonstration where-ever required will have to be done by the firm free of cost by their representative/engineer.
19. The items required are for the CAZRI, RRS, Bikaner and therefore, supply to be made accordingly.
20. A committee of the Institute may inspect the items before finalize the itams. A sample of each item may be kept ready/get available at this Institute/firm showroom on request of the Institute.
21. Manufactures Authorization Certificate in case the bidder is quoting as an agent on behalf of a manufacturer may be attached with the tender.
22. The Authorized Agent/Dealer should have facility of the after sales service, repairing of the Drip system after warranty period may also be mentioned in the tender.
23. Copy of PAN/ITCC issued by Deptt. of Income Tax may be submitted with the tender.
24. Copy of Sales Tax /CST clearance certificate may be attached with the tender.
